TURF-COTE colorant is a concentrated 100% acrylic water based product. It will not harm plants, animals, or fish. TURF-COTE is non-combustible and non-hazardous.

Color: BERMUDA

The concentrate color is intense and it is recommended that lower rates be applied with maximum water to produce a transition color. Increasing the colorant application rate and reducing the amount of water will intensify the color.

Sports Fields-----10-15 GPA*
Football Fields-----15-20 GPA*
Lawns-----25-5 GPA*

* Will vary based on color requirements

Product is engineered to last an entire season with one application at higher rates. However for golf courses and sports fields, it is recommended that 2-3 light applications be made to insure the desired depth of color.

Application Method:

Spray *TURF-COTE* with one part product to 5-10 parts water. Less water may be used to increase the green coloring. Use only cool clean water. Apply in one direction and then apply perpendicular to the first. DO NOT APPLY when the ambient temperature is below 50 degrees F, or when the turf/soil temperature exceeds 140 degrees F. Do not apply when rain is imminent.

Allow a minimum of one (1) hour of drying.

Tank Mixing Instructions:

Gradually add *TURF-COTE* to the tank while filling. DO NOT POUR INTO EMPTY TANK OR WHEN TANK IS COMPLETELY FULL. Agitate well during filling and application. Clean sprayer tank thoroughly after use. Unused mixture may be sealed and used at a later date.
